# A MINIMISATION PROBLEM IN L ${ }^{\infty}$ WITH PDE AND UNILATERAL CONSTRAINTS 

NIKOS KATZOURAKIS


#### Abstract

We study the minimisation of a cost functional which measures the misfit on the boundary of a domain between a component of the solution to a certain parametric elliptic PDE system and a prediction of the values of this solution. We pose this problem as a PDE-constrained minimisation problem for a supremal cost functional in $L^{\infty}$, where except for the PDE constraint there is also a unilateral constraint on the parameter. We utilise approximation by PDE-constrained minimisation problems in $\mathrm{L}^{p}$ as $p \rightarrow \infty$ and the generalised Kuhn-Tucker theory to derive the relevant variational inequalities in $\mathrm{L}^{p}$ and $\mathrm{L}^{\infty}$. These results are motivated by the mathematical modelling of the novel bio-medical imaging method of Fluorescent Optical Tomography.


## 1. Introduction

Let $\Omega \subseteq \mathbb{R}^{n}$ be an open bounded set with $\mathrm{C}^{1}$ boundary $\partial \Omega$ and let also $n \geq 3$. Consider the next Robin boundary value problem for a pair of coupled linear elliptic systems:

where $u, v: \Omega \longrightarrow \mathbb{R}^{2}$ are the solutions, $\mathrm{n}: \partial \Omega \longrightarrow \mathbb{R}^{n}$ is the outer unit normal vector field on $\partial \Omega$ and the coefficients $\mathrm{A}, \mathrm{B}, \mathrm{K}, \mathrm{L}, \mathrm{M}, s, S, \xi, \gamma$ satisfy $\gamma>0$ and

Here the matrix-valued maps $\mathrm{K}, \mathrm{L}$ are assumed to have the form

[^0]We note that our general notation will be either standard or self-explanatory, as e.g. in the textbooks [24, 41]. The PDE problem above (where the coefficient $\xi$ is considered as a parameter) arises in Fluorescent Optical Tomography, which is a new and evolving bio-medical imaging method with wider industrial applications. Optical tomography is being very intensely studied, as it presents some pros over standard imaging methods which use X-rays, Gamma-rays, electromagnetic radiation and ultrasounds. In particular, it is less harmful for living organisms and more precise. In this setting, the coefficients take the form

where $I_{3}$ is the identity matrix in $\mathbb{R}^{3}$. In the above, the coefficients $A, B$ describe the diffusion of photons, $\mu_{s}^{\prime}$ is the reduced scattering coefficient, $\phi$ is the quantum efficiency of the fluorophore, $\mu_{a i}$ is the absorption coefficient due to the endogenous chromophores, $\tau$ is the fluorophore lifetime, $\xi$ is the absorption coefficient due to the exogenous fluorophore and $\omega$ is the modulated light frequency and c the speed of light. Finally, $S, s$ are light sources.

Technically, the aim of optical tomography is to reconstruct $\xi$ in the domain from measurements of light intensity on the boundary. A fluorescent dye is injected into $\Omega$. In order to determine the dye concentration $\xi, \Omega$ is illuminated by a light source $s=s(x)$ placed on the boundary $\partial \Omega$. The light diffuses inside $\Omega$, and wherever dye is present, infrared light is emitted that can then be detected again on the boundary through appropriate sensors. The goal is then to reconstruct $\xi$ from the obtained boundary images. For more details we refer to $[1,3,11,12,13,25,27,31$, $34,35,49,51]$.

In this paper, motivated by the problem of optical tomography and by the recent developments in Calculus of Variations in $L^{\infty}$ appearing in the papers [38, 39, 40], we consider the problem of minimising over the class of all admissible parameters $\xi$ a certain cost functional which measures the deviation of the solution $v$ on the boundary $\partial \Omega$ from some prediction $\tilde{v}$ of its values. Given the high complexity of the optical tomography problem, in this work which is the companion paper of [37] we will make the simplifying assumption that the diffusion coefficients A, B and the optical terms K, L do not depend explicitly on the dye distribution. On the other hand, though, we allow for potentially different diffusions and coefficients in the two systems describing the red and the infrared light. To this end, fix $N \in \mathbb{N}$, $m \in[n, \infty)$ and $p>\max \{n, 2 n /(n-2)\}$. Consider Borel sets

be predicted (noisy) values of the solution $v$ of (1.1)(b)-(1.1)(d) on the boundary $\partial \Omega$. Suppose that for any $i \in\{1, \ldots, N\}$, the pair $\left(u_{i}, v_{i}\right)$ solves (1.1) with coefficiens $\left(S_{i}, s_{i}, \xi\right)$. For the $N$-tuple of solutions $\left(u_{1}, \ldots, u_{N} ; v_{1}, \ldots, v_{N}\right)$, we will symbolise

Our aim is to determine some $\xi \in \mathrm{L}^{p}(\Omega,[0, \infty))$ such that all the misfits

between the predicted approximate solution and the actual solution are minimal. We will minimise the error in $\mathrm{L}^{\infty}$ by means of approximations in $\mathrm{L}^{p}$ for large $p$ and then take the limit $p \rightarrow \infty$. By minimising in $\mathrm{L}^{\infty}$ one can achieve uniformly small cost, rather than on average. Since no reasonable cost functional is coercive in our admissible class, we will therefore follow two different approaches to rectify this problem, but in a unified fashion. The first and more popular idea is to add a Tykhonov-type regularisation term $\alpha\|\xi\|$ for small $\alpha>0$ and some appropriate norm. The alternative approach is to consider that an a priori $L^{\infty}$ bound is given on $\xi$. The latter approach appears to be more natural for applications, as it does not alter the error functional. For finite $p<\infty$, we can relax this to an $\mathrm{L}^{p}$ bound, but as we are mostly interested in the limit case $p=\infty$, we will only discuss the case of $L^{\infty}$ bound. In view of the above observations, we define the integral functional

The slashed integrals denote the average with respect to the Lebesgue measure $\mathcal{L}^{n}$ and the Hausdorff measure $\mathcal{H}^{n-1}$ respectively and $|\cdot|_{(p)}$ is a regularisation of the Euclidean norm away from zero in the corresponding space, given by

Note that $\mathfrak{X}^{\infty}(\Omega)$ is a subset of a Frechét space, rather than of a Banach space, but no difficulties will emerge out of this. We will assume that the pair of parameters $\alpha, M \in[0, \infty]$ satisfy either of the two conditions:

Namely, if we have non-zero regularisation parameter $\alpha$, then no upper $\mathrm{L}^{\infty}$ bound $M$ is required, but if the parameter $\alpha$ vanishes we need an upper $\mathrm{L}^{\infty}$ bound $M$.

Our first main result concerns the existence of $\mathrm{I}_{p}$-minimisers in $\mathfrak{X}^{p}(\Omega)$, the existence of $\mathrm{I}_{\infty}$-minimisers in $\mathfrak{X}^{\infty}(\Omega)$ and the approximability of the latter by the former as $p \rightarrow \infty$.

Theorem 1 ( $\mathrm{I}_{\infty}$-misfit minimisers, $\mathrm{I}_{p}$-misfit minimisers \& convergence as $p \rightarrow \infty$ ). (A) The functional $\mathrm{I}_{p}$ has a constrained minimiser $\left(\vec{u}_{p}, \vec{v}_{p}, \xi_{p}\right)$ in the admissible class $\mathfrak{X}^{p}(\Omega)$ :

Given the existence of constrained minimisers established by Theorem 1 above, the next natural question concerns the existence of necessary conditions in the form of PDEs governing the constrained minimisers. Unlike the case of unconstrained minimisation, no analogue of Euler-Lagrange equations is available in this case. One the one hand, the PDE constraints will give rise to Lagrange multipliers which are functionals. On the other hand, the unilateral constraint on $\xi$ gives rise to a variational differential inequality, rather than an equation. This generalised variational context of extrema with constraints is known as the Kuhn-Tucker theory (see e.g. [50]). Hence, our next main result regarding the variational inequalities for finite $p$ is given below.

Theorem 2 (Variational inequalities in $\mathrm{L}^{p}$ ). For any $p>\max \{n, 2 n /(n-2)\}$, there exist Lagrange multipliers

Note that the measures $\vec{\nu}_{p}(\vec{v})$ and $\mu_{p}(\xi)$ are absolutely continuous with respect to the Hausdorff measure $\mathcal{H}^{n-1}\left\llcorner_{\partial \Omega}\right.$ and the Lebesgue measure $\mathcal{L}^{n}\left\llcorner_{\Omega}\right.$ respectively. In general, $\mu_{p}(\xi)$ is signed if $\xi \in \mathrm{L}^{p}(\Omega)$, but due to the constraint we have $\mu_{p}\left(\xi_{p}\right) \geq 0$. Further, $\left\{e_{1}, \ldots, e_{N}\right\}$ symbolises the standard Euclidean basis of $\mathbb{R}^{N}$, ":" symbolises the standard inner product in $\mathbb{R}^{2 \times N}$, and $\mathrm{d}\left[\mu_{p}\left(\xi_{p}\right)\right] / \mathrm{d} \mathcal{L}^{n}$ symbolises the RadonNikodyn derivative of $\mu_{p}\left(\xi_{p}\right)$ with respect to $\mathcal{L}^{n}$. The reason we obtain three different relations of which one is inequality and two are equations is the following. If we ignore the PDE constraints in (1.13), then the admissible class is the Cartesian
product of two vector spaces (spaces for $\vec{u}$ and $\vec{v}$ ), and a convex set (space of $\xi$, see also (2.25) that follows). Since the unilateral constraint is only for $\xi$, the variational inequality arises only for this variable. The decoupling of these relations is a consequence of linear independence.

Our final main result is the limiting counterpart of Theorem 2 for the constrained minimiser of the $\infty$-problem. To this aim, let us set

(I) If $C_{\infty}=0$ and $\alpha>0$, then $\xi_{\infty}=0$ a.e. on $\Omega$ and $\vec{\nu}_{\infty}=\overrightarrow{0}$.
(II) If $C_{\infty}>0$, then there exist (rescaled) limiting Lagrange multipliers

In this case, the constrained minimiser $\left(\vec{u}_{\infty}, \vec{v}_{\infty}, \xi_{\infty}\right) \in \mathfrak{X}^{\infty}(\Omega)$ satisfies the next three relations:

We conclude this lengthy introduction with some comments about the general variational context we use herein. Calculus of Variations in $L^{\infty}$ is a modern subarea of analysis pioneered by Aronsson in the 1960s (see [6]-[9]) who considered variational problems of supremal functionals, rather than integral functional. For a pedagogical introduction we refer e.g. to [20, 36]. Except for their endogenous mathematical appeal, $L^{\infty}$ cost-error functionals are important for applications because by minimising their supremum rather than their average (as e.g. in standard $L^{2}$ approaches), we obtain improved performance/predictions/fitting. Indeed, minimisation of the supremum of the misfit guarantees uniform smallness, namely deviation spikes of small volume are excluded. Interesting results regarding $L^{\infty}$ variational problems can be found e.g. in $[10,14,15,16,17,18,19,28,43,46,47,48]$.

## 2. Proofs

We begin with an auxiliary result of independent interest, namely the wellposedness of general Robin boundary value problems for linear systems.
Theorem 4 (Well-posedness in $\mathrm{W}^{1,2}$ and $\mathrm{W}^{1, p}$ ). Let $\Omega \Subset \mathbb{R}^{n}$ be a domain with $\mathrm{C}^{1}$ boundary and let $\mathrm{n}: \partial \Omega \longrightarrow \mathbb{R}^{n}$ be the outer unit normal. Consider the boundary value problem

then, (2.1) has a unique weak solution in $\mathrm{W}^{1,2}\left(\Omega ; \mathbb{R}^{2}\right)$ satisfying

for all $\phi \in \mathrm{W}^{1,2}\left(\Omega ; \mathbb{R}^{2}\right)$. In addition, exists $C>0$ depending only on the coefficients such that

In the proofs that follow we will employ the standard practice of denoting by $C$ a generic constant whose value might change from step to step in an estimate.

Proof. The aim is to apply of the Lax Milgram theorem. (Note that the matrix K is not symmetric, thus this is not a direct consequence of the Riesz theorem.) We define the bilinear functional

for any $u \in W^{1,2}\left(\Omega ; \mathbb{R}^{2}\right)$. Hence, the bilinear form $\mathbb{B}$ is continuous and coercive, thus the hypotheses of the Lax-Milgram theorem are satisfied (see e.g. [24]). Hence, for any $\Phi \in\left(\mathrm{W}^{1,2}\left(\Omega ; \mathbb{R}^{2}\right)\right)^{*}$, exists a unique $u \in \mathrm{~W}^{1,2}\left(\Omega ; \mathbb{R}^{2}\right)$ such that

We conclude with the claimed $\mathrm{L}^{2}$ estimate by combining the above estimate with our lower bound on $\mathbb{B}[u, u]$.

Now we turn to the higher integrability of the weak solution. The main ingredient is to apply a well-know estimate for the Robin boundary value problem which has the form (2.6), but applies to the scalar version of (2.1) for $K \equiv 0$, see e.g. [5, 21, 23, 29, 33, 42, 44, 45]. Hence, we need to show that it is still true in the general case of (2.1). To this end, we rewrite (2.1) componentwise as

for $i=1,2$. Note now that since we have assumed $p>2 n /(n-2)$, we have $2<n p /(n+p)<p$. Hence, by the $\mathrm{L}^{p}$ interpolation inequalities, we can estimate

& =\varepsilon\|u\|_{\mathrm{L}^{p}(\Omega)}+\left[\frac{2 p}{n(p-2)}\left(\frac{\varepsilon n(p-2)}{p(n-2)-2 n}\right)^{-\frac{p(n-2)-2 n}{2 p}}\right]\|u\|_{\mathrm{L}^{2}(\Omega)} .

By (2.7) and (2.9) and by choosing $\varepsilon>0$ small, we infer

As a consequence of our result above, we show that the (forward) Robin problem (1.1) is well posed.

Corollary 5 (Well-posedness of (1.1)). Consider (1.1) and suppose that the coefficients A, B, K, L, M, $\xi$, s, S satisfy (1.2)-(1.4). We further assume that for some $m \geq n$ we have

\|u\|_{\mathrm{W}^{1, \frac{m}{2}}(\Omega)} & \leq C\left(\|s\|_{\mathrm{L}^{\frac{m}{2}}(\partial \Omega)}+\|S\|_{L^{\frac{n m}{2 n+m}(\Omega)}}\right)  \tag{2.12}\\
\|v\|_{\mathrm{W}^{1, p}(\Omega)} & \leq C\|\xi\|_{\mathrm{L}^{p}(\Omega)}\|u\|_{\mathrm{L}^{m}(\Omega)}
\end{align*}\right.
$$

Proof. By Theorem 4 applied to the Robin problem (1.1)(a)-(1.1)(c) for $p=m / 2$ and by recalling that

$$
\frac{m}{2} \geq \frac{n}{2}>\frac{2 n}{n-2}
$$

for any $s \in \mathrm{~L}^{\frac{m}{2}}\left(\partial \Omega ; \mathbb{R}^{2}\right)$ and $S \in L^{\frac{n m}{2 n+m}}\left(\Omega ; \mathbb{R}^{2}\right)$ exists a unique $u \in \mathrm{~W}^{1, \frac{m}{2}}\left(\Omega ; \mathbb{R}^{2}\right)$ satisfying the $u$-system in (2.11) for all $\phi \in \mathrm{W}^{1, \frac{m}{m-2}}\left(\Omega ; \mathbb{R}^{2}\right)$, as well as the estimate (2.12) for $u$. Fix now $\xi \in \mathrm{L}^{p}(\Omega)$. By Theorem 4 applied to the Robin boundary value problem $(1.1)(\mathrm{b})-(1.1)(\mathrm{d})$, it will follow there exists a unique $v \in \mathrm{~W}^{1, p}\left(\Omega ; \mathbb{R}^{2}\right)$ satisfying the $v$-system in (2.11) for all $\psi \in \mathrm{W}^{1, \frac{p}{p-1}}\left(\Omega ; \mathbb{R}^{2}\right)$, once we have verified that $\xi \mathrm{M} u \in \mathrm{~L}^{\frac{n p}{n+p}}(\Omega)$. By (2.6) and Hölder's inequality, we estimate

$$
\begin{aligned}
\|v\|_{\mathrm{W}^{1, p}(\Omega)} & \leq C\|\xi \mathrm{M} u\|_{\mathrm{L}^{\frac{n p}{n+p}}(\Omega)} \\
& \leq C\|\xi\|_{\mathrm{L}^{\frac{n p r}{n+p}}(\Omega)}\|u\|_{\mathrm{L}^{\frac{n p r^{\prime}}{n+p}}(\Omega)},
\end{aligned}
$$

for a new $C>0$ and any $r>1$. We select $r:=(n+p) / p$ to obtain

$$
\frac{n p r^{\prime}}{n+p}=\frac{n p}{n+p} \frac{p+n}{p}=n
$$

Hence, we conclude that

$$
\|v\|_{\mathrm{W}^{1, p}(\Omega)} \leq C\|\xi\|_{\mathrm{L}^{p}(\Omega)}\|u\|_{\mathrm{L}^{n}(\Omega)} \leq C\|\xi\|_{\mathrm{L}^{p}(\Omega)}\|u\|_{\mathrm{L}^{m}(\Omega)},
$$

because $m \geq n$. The proof is complete.

Now we establish Theorem 1. Its proof is a consequence of the next two propositions, utilising the direct method of Calculus of Variations ([21]).

Proposition 6 ( $\mathrm{I}_{p}$-minimisers). In the context of Theorem 1, the functional $\mathrm{I}_{p}$ has a constrained minimiser $\left(\vec{u}_{p}, \vec{v}_{p}, \xi_{p}\right) \in \mathfrak{X}^{p}(\Omega)$, as per (1.17).

Proof. Note that $\mathfrak{X}^{p}(\Omega) \neq \emptyset$, and in fact $\mathfrak{X}^{p}(\Omega)$ is a weakly closed subset of the reflexive Banach space $\mathscr{X}^{p}(\Omega)$ with cardinality greater or equal to that of $\mathrm{L}^{p}(\Omega)$. Further, there is an a priori energy bound for the infimum of $\mathrm{I}_{p}$, in fact uniform in $p$. Indeed, for each $i \in\{1, \ldots, N\}$ let $\left(u_{0 i}, v_{0 i}\right)$ be the solution to (1.1) with $\xi \equiv 0$ and $\left(S_{i}, s_{i}\right)$ as in (1.6). Then, by Corollary 5, we have $v_{0 i} \equiv 0$. Therefore, by (1.9)-(1.10) we infer that

$$
\left(\vec{u}_{0}, \overrightarrow{0}, 0\right) \in \mathfrak{X}^{p}(\Omega)
$$

for all $p \in[n, \infty]$, and also, by Hölder inequality and (1.7)-(1.11), we obtain

$$
\mathrm{I}_{p}\left(\vec{u}_{0}, \overrightarrow{0}, 0\right) \leq \frac{N+1}{p}+E_{\infty}\left(\vec{u}_{0}, \overrightarrow{0}, 0\right) \leq \frac{N+1}{n}+\sum_{i=1}^{N}\left\|\tilde{v}_{i}\right\|_{\mathrm{L}^{\infty}\left(\mathrm{B}_{i}\right)}<\infty .
$$

Fix $p$ and consider now a minimising sequence $\left(\vec{u}^{j}, \vec{v}^{j}, \xi^{j}\right)_{j=1}^{\infty}$ of $\mathrm{I}_{p}$ in $\mathfrak{X}^{p}(\Omega)$. Then, for any large enough $j \in \mathbb{N}$ we have

$$
0 \leq \mathrm{I}_{p}\left(\vec{u}^{j}, \vec{v}^{j}, \xi^{j}\right) \leq \frac{N+1}{n}+\sum_{i=1}^{N}\left\|\tilde{v}_{i}\right\|_{\mathrm{L}^{\infty}\left(\mathrm{B}_{i}\right)}+1
$$

By Corollary 5, we have the estimates

$$
\left\{\begin{align*}
\left\|\vec{u}^{j}\right\|_{\mathrm{W}^{1, \frac{m}{2}}(\Omega)} & \leq C \max _{i=1, \ldots, N}\left(\left\|S_{i}\right\|_{L^{\frac{n m}{2 n+m}(\Omega)}}+\left\|s_{i}\right\|_{\mathrm{L}^{\frac{m}{2}}(\partial \Omega)}\right)  \tag{2.13}\\
\left\|\vec{v}^{j}\right\|_{\mathrm{W}^{1, p}(\Omega)} & \leq C\left\|\xi^{j}\right\|_{\mathrm{L}^{p}(\Omega)}\left\|\vec{u}^{j}\right\|_{\mathrm{W}^{1, \frac{m}{2}}(\Omega)}
\end{align*}\right.
$$

If (1.15) is satisfied, then by all the above and (1.8) we have the estimate

$$
\left\|\xi^{j}\right\|_{\mathrm{L}^{p}(\Omega)} \leq\left\|\xi^{j}\right\|_{\dot{\mathrm{L}}^{p}(\Omega)} \leq \frac{1}{\alpha}\left(\frac{N+1}{n}+\sum_{i=1}^{N}\left\|\tilde{v}_{i}\right\|_{\mathrm{L}^{\infty}\left(\mathrm{B}_{i}\right)}+1\right)
$$

If on the other hand (1.16) is satisfied, then we readily have

$$
\left\|\xi^{j}\right\|_{\mathrm{L}^{p}(\Omega)} \leq\left\|\xi^{j}\right\|_{\mathrm{L}^{\infty}(\Omega)} \leq M
$$

Hence, in both cases of either (1.15) or (1.16), we have the uniform bound

$$
\begin{equation*}
\sup _{j \in \mathbb{N}}\left\|\xi^{j}\right\|_{L^{p}(\Omega)}<\infty \tag{2.14}
\end{equation*}
$$

By the estimates (2.13)-(2.16) and standard weak and strong compactness arguments, there exists a weak limit in the Banach space

$$
\left(\vec{u}_{p}, \vec{v}_{p}, \xi_{p}\right) \in \mathscr{X}^{p}(\Omega)
$$

and a subsequence $\left(j_{k}\right)_{1}^{\infty}$ such that as $j_{k} \rightarrow \infty$ we have

$$
\begin{cases}\xi^{j} \longrightarrow \xi_{p}, & \text { in } \mathrm{L}^{p}(\Omega) \\ \vec{u}^{j} \longrightarrow \vec{u}_{p}, & \text { in } \mathrm{W}^{1, \frac{m}{2}}\left(\Omega ; \mathbb{R}^{2 \times N}\right) \\ \vec{u}^{j} \longrightarrow \vec{u}_{p}, & \text { in } \mathrm{L}^{\frac{m}{2}}\left(\Omega ; \mathbb{R}^{2 \times N}\right) \\ \vec{v}^{j} \longrightarrow \vec{v}_{p}, & \text { in } \mathrm{W}^{1, p}\left(\Omega ; \mathbb{R}^{2 \times N}\right) \\ \vec{v}^{j} \longrightarrow \vec{v}_{p}, & \text { in } \mathrm{C}^{0}\left(\bar{\Omega} ; \mathbb{R}^{2 \times N}\right)\end{cases}
$$

Note that in this paper we utilise the standard practice of passing to subsequences as needed perhaps without explicit mention. To show that $\left(\vec{u}_{p}, \vec{v}_{p}, \xi_{p}\right)$ lies in $\mathfrak{X}^{p}(\Omega)$, we argue as follows. First we show that for any $M \in[0, \infty]$ the constraint

$$
0 \leq \xi^{j} \leq M \text { a.e. on } \Omega
$$

is weakly closed in $\mathrm{L}^{p}(\Omega)$, namely

$$
\begin{equation*}
\mathrm{L}^{p}(\Omega ;[0, M])=\left\{\eta \in \mathrm{L}^{p}(\Omega): 0 \leq \eta \leq M \text { a.e. on } \Omega\right\} \tag{2.15}
\end{equation*}
$$

is weakly closed. To this aim, let $\xi^{j} \longrightarrow \xi_{p}$ in $\mathrm{L}^{p}(\Omega)$ as $j_{k} \rightarrow \infty$. Then, for any measurable set $E \subseteq \Omega$ with positive measure $\mathcal{L}^{n}(E)>0$, by integrating the last inequality over $E$, the averages satisfy

$$
0 \leq f_{E} \xi^{j} \mathrm{~d} \mathcal{L}^{n} \leq M
$$

and therefore

$$
f_{E} \xi_{p} \mathrm{~d} \mathcal{L}^{n}=\lim _{j_{k} \rightarrow \infty}\left(f_{E} \xi^{j} \mathrm{~d} \mathcal{L}^{n}\right) \in[0, M]
$$

By selecting $E:=\mathbb{B}_{\rho}(x)$ for $x \in \Omega$ and $\rho \in(0, \operatorname{dist}(x, \partial \Omega))$, the Lebesgue differentiation theorem allows us to infer

$$
\xi_{p}(x)=\lim _{\rho \rightarrow 0}\left(f_{\mathbb{B}_{\rho}(x)} \xi_{p} \mathrm{~d} \mathcal{L}^{n}\right) \in[0, M], \quad \text { for a.e. } x \in \Omega
$$

To conclude that $\left(\vec{u}_{p}, \vec{v}_{p}, \xi_{p}\right) \in \mathfrak{X}^{p}(\Omega)$, we must pass to the weak limit in the equations $(a)_{i}-(d)_{i}$ in (1.13). The only convergence that needs to be justified that of the nonlinear source term $\xi \mathrm{M} u_{i}$ in $(b)_{i}$. To this end, note that by our assumption $p>\frac{2 n}{n-2}$, we have the inequality

$$
\frac{p}{p-1}<\frac{n}{2} \leq \frac{m}{2}
$$

Thus, since $u_{i}^{j} \longrightarrow u_{p i}$ in $\mathrm{L}^{\frac{m}{2}}\left(\Omega ; \mathbb{R}^{2}\right)$ as $j_{k} \rightarrow \infty$, we have that

$$
u_{i}^{j} \longrightarrow u_{p i} \quad \text { in } \mathrm{L}^{\frac{p}{p-1}}\left(\Omega ; \mathbb{R}^{2}\right)
$$

as $j_{k} \rightarrow \infty$. Hence, since $\xi^{j} \longrightarrow \xi_{p}$ in $\mathrm{L}^{p}(\Omega)$, it follows that

$$
\int_{\Omega}\left(\xi^{j} \mathrm{M} u_{i}^{j}\right) \cdot \phi \mathrm{d} \mathcal{L}^{n} \longrightarrow \int_{\Omega}\left(\xi_{p} \mathrm{M} u_{p i}\right) \cdot \phi \mathrm{d} \mathcal{L}^{n}
$$

for any $\phi \in \mathrm{C}_{c}^{\infty}\left(\Omega ; \mathbb{R}^{2}\right)$ as $j_{k} \rightarrow \infty$, as a consequence of the weak-strong continuity of the duality pairing between $\mathrm{L}^{p}(\Omega)$ and $\mathrm{L}^{\frac{p}{p-1}}(\Omega)$. In conclusion, we infer that indeed $\left(\vec{u}_{p}, \vec{v}_{p}, \xi_{p}\right) \in \mathfrak{X}^{p}(\Omega)$ by passing to the weak limit in the equations $(a)_{i}-(d)_{i}$ defining (1.13).

We now show that $\left(\vec{u}_{p}, \vec{v}_{p}, \xi_{p}\right) \in \mathfrak{X}^{p}(\Omega)$ is indeed a minimiser of $\mathrm{I}_{p}$. To this aim, note that for any $\alpha \in[0, \infty)$ the functional $\alpha\|\cdot\|_{\dot{L}^{p}(\Omega)}$ is convex and strongly continuous on the reflexive space $\mathrm{L}^{p}(\Omega)$, by (1.10)-(1.11). Thus, it is weakly lower semi-continuous. Similarly, note that for each index $i \in\{1, \ldots, N\}$ the functional $\left\|\cdot-\tilde{v}_{i}\right\|_{\mathrm{L}^{p}\left(\mathrm{~B}_{i}\right)}$ is strongly continuous on $\mathrm{L}^{p}\left(\mathrm{~B}_{i}\right)$. In conclusion, we have

$$
\begin{aligned}
\mathrm{I}_{p}\left(\vec{u}_{p}, \vec{v}_{p}, \xi_{p}\right) & =\alpha\left\|\xi_{p}\right\|_{\dot{\mathrm{L}}^{p}(\Omega)}+\sum_{i=1}^{N}\left\|v_{p i}-\tilde{v}_{i}\right\|_{\dot{\mathrm{L}}^{p}\left(\mathrm{~B}_{i}\right)} \\
& \leq \liminf _{j_{k} \rightarrow \infty}\left\{\alpha\left\|\xi^{j}\right\|_{\dot{\mathrm{L}}^{p}(\Omega)}+\sum_{i=1}^{N}\left\|v_{i}^{j}-\tilde{v}_{i}\right\|_{\dot{\mathrm{L}}^{p}\left(\mathrm{~B}_{i}\right)}\right\} \\
& =\liminf _{j_{k} \rightarrow \infty} \mathrm{I}_{p}\left(\vec{u}^{j}, \vec{v}^{j}, \xi^{j}\right) \\
& =\inf \left\{\mathrm{I}_{p}(\vec{u}, \vec{v}, \xi):(\vec{u}, \vec{v}, \xi) \in \mathfrak{X}^{p}(\Omega)\right\}
\end{aligned}
$$

The proposition ensues.

Our next result below establishes the existence of minimisers for $I_{\infty}$ and the approximation by minimisers of the $\mathrm{I}^{p}$ functionals as $p \rightarrow \infty$, therefore completing the proof of Theorem 1.

Proposition 7 ( $\mathrm{I}_{\infty}$-minimisers). The functional $\mathrm{I}_{\infty}$ given by (1.9) has a constrained minimiser $\left(\vec{u}_{\infty}, \vec{v}_{\infty}, \xi_{\infty}\right) \in \mathfrak{X}^{\infty}(\Omega)$, as in (1.18). Additionally, exists a subsequence $\left(p_{j}\right)_{1}^{\infty}$ such that the $\mathrm{I}_{p_{j}}$-minimisers $\left(\vec{u}_{p_{j}}, \vec{v}_{p_{j}}, \xi_{p_{j}}\right)$ satisfy (1.19) as $j \rightarrow \infty$.

Proof. We continue from the proof of Proposition 6. The map $\left(\vec{u}_{0}, \overrightarrow{0}, 0\right)$ constructed therein provides an energy bound uniform in $p$ and in view of (1.13)-(1.14) we also have $\left(\vec{u}_{0}, \overrightarrow{0}, 0\right) \in \mathfrak{X}^{\infty}(\Omega)$. Fix $q>n$ and $p \geq q$. By Hölder inequality and minimality, we estimate

$$
\begin{aligned}
\mathrm{I}_{q}\left(\vec{u}_{p}, \vec{v}_{p}, \xi_{p}\right) & \leq \mathrm{I}_{p}\left(\vec{u}_{p}, \vec{v}_{p}, \xi_{p}\right) \\
& \leq \mathrm{I}_{p}\left(\vec{u}_{0}, \overrightarrow{0}, 0\right) \\
& \leq \mathrm{I}_{\infty}\left(\vec{u}_{0}, \overrightarrow{0}, 0\right)+\frac{N+1}{n} \\
& \leq \sum_{i=1}^{N}\left\|\tilde{v}_{i}\right\|_{\mathrm{L}^{\infty}\left(\mathrm{B}_{i}\right)}+\frac{N+1}{n}
\end{aligned}
$$

which is uniform in $p$. If (1.15) is satisfied, then by the above estimate we have

$$
\left\|\xi_{p}\right\|_{\mathrm{L}^{q}(\Omega)} \leq\left\|\xi_{p}\right\|_{\dot{\mathrm{L}}^{p}(\Omega)} \leq \frac{1}{\alpha}\left(\sum_{i=1}^{N}\left\|\tilde{v}_{i}\right\|_{\mathrm{L}^{\infty}\left(\mathrm{B}_{i}\right)}+\frac{N+1}{n}\right)
$$

If on the other hand (1.16) is satisfied, then we immediately have

$$
\left\|\xi_{p}\right\|_{\mathrm{L}^{q}(\Omega)} \leq\left\|\xi_{p}\right\|_{\mathrm{L}^{\infty}(\Omega)} \leq M
$$

Hence, in both cases of either (1.15) or (1.16), we have the uniform bound

$$
\begin{equation*}
\sup _{p \geq q}\left\|\xi_{p}\right\|_{\mathrm{L}^{q}(\Omega)}<\infty \tag{2.16}
\end{equation*}
$$

By the above estimates, Corollary 5 (see (2.13)) and standard compactness arguments yield that there exists a subsequence $\left(p_{j}\right)_{1}^{\infty}$ and a limit

$$
\left(\vec{u}_{\infty}, \vec{v}_{\infty}, \xi_{\infty}\right) \in \bigcap_{n<q<\infty} \mathcal{W}^{q}(\Omega)
$$

such that (1.19) holds true as $j \rightarrow \infty$. In addition, under either assumptions (1.15) or (1.16) we have that $\xi_{\infty} \in \mathrm{L}^{\infty}(\Omega)$. Indeed, under (1.15) by integrating the constraint $0 \leq \xi_{p} \leq M$ on a measurable set $E \subseteq \Omega$ of positive measure we have

$$
0 \leq f_{E} \xi_{p} \mathrm{~d} \mathcal{L}^{n} \leq M
$$

and therefore

$$
f_{E} \xi_{\infty} \mathrm{d} \mathcal{L}^{n}=\lim _{p_{j} \rightarrow \infty}\left(f_{E} \xi_{p} \mathrm{~d} \mathcal{L}^{n}\right) \in[0, M]
$$

Then, for $E:=\mathbb{B}_{\rho}(x), x \in \Omega$ and $\rho \in(0, \operatorname{dist}(x, \partial \Omega))$ we deduce

$$
\xi_{\infty}(x)=\lim _{\rho \rightarrow 0}\left(f_{\mathbb{B}_{\rho}(x)} \xi_{\infty} \mathrm{d} \mathcal{L}^{n}\right) \in[0, M], \quad \text { for a.e. } x \in \Omega
$$

for any $M>0$. If on the other hand (1.15) is satisfied, then by the weak lowersemicontinuity of the functional $\|\cdot\|_{\dot{\mathrm{L}}^{q}(\Omega)}$ on $\mathrm{L}^{q}(\Omega)$, we have

$$
\begin{aligned}
\left\|\xi_{\infty}\right\|_{\mathrm{L}^{\infty}(\Omega)} & =\lim _{q \rightarrow \infty}\left\|\xi_{\infty}\right\|_{\dot{\mathrm{L}}^{q}(\Omega)} \\
& \leq \liminf _{q \rightarrow \infty}\left(\liminf _{p_{j} \rightarrow \infty}\left\|\xi_{p}\right\|_{\dot{\mathrm{L}}^{q}(\Omega)}\right) \\
& \leq \liminf _{q \rightarrow \infty}\left(\liminf _{p_{j} \rightarrow \infty} \frac{1}{\alpha} \sum_{i=1}^{N}\left\|\tilde{v}_{i}\right\|_{\mathrm{L}^{\infty}\left(\mathrm{B}_{i}\right)}\right) \\
& =\frac{1}{\alpha} \sum_{i=1}^{N}\left\|\tilde{v}_{i}\right\|_{\mathrm{L}^{\infty}\left(\mathrm{B}_{i}\right)}
\end{aligned}
$$

Further, by passing to the limit as $p_{j} \rightarrow \infty$ in $(a)_{i}-(d)_{i}$ of (1.13) as in the proof of Proposition 6 , we see that the limit $\left(\vec{u}_{\infty}, \vec{v}_{\infty}, \xi_{\infty}\right)$ lies in $\mathfrak{X}^{\infty}(\Omega)$. It remains to prove that $\left(\vec{u}_{\infty}, \vec{v}_{\infty}, \xi_{\infty}\right)$ is a minimiser of $\mathrm{I}_{\infty}$ and that the energies converge. Fix an arbitrary $(\vec{u}, \vec{v}, \xi) \in \mathfrak{X}^{\infty}(\Omega)$. Since $p_{j} \geq q$ for large $j \in \mathbb{N}$, by minimality we have

$$
\begin{aligned}
\mathrm{I}_{\infty}\left(\vec{u}_{\infty}, \vec{v}_{\infty}, \xi_{\infty}\right) & =\lim _{q \rightarrow \infty} \mathrm{I}_{q}\left(\vec{u}_{\infty}, \vec{v}_{\infty}, \xi_{\infty}\right) \\
& \leq \liminf _{q \rightarrow \infty}\left(\liminf _{p_{j} \rightarrow \infty} \mathrm{I}_{q}\left(\vec{u}_{p}, \vec{v}_{p}, \xi_{p}\right)\right) \\
& \leq \liminf _{p_{j} \rightarrow \infty} \mathrm{I}_{p}\left(\vec{u}_{p}, \vec{v}_{p}, \xi_{p}\right) \\
& \leq \limsup _{p_{j} \rightarrow \infty} \mathrm{I}_{p}\left(\vec{u}_{p}, \vec{v}_{p}, \xi_{p}\right) \\
& \leq \limsup _{p_{j} \rightarrow \infty} \mathrm{I}_{p}(\vec{u}, \vec{v}, \xi) \\
& =\mathrm{I}_{\infty}(\vec{u}, \vec{v}, \xi)
\end{aligned}
$$

for any $(\vec{u}, \vec{v}, \xi) \in \mathfrak{X}^{\infty}(\Omega)$. Therefore, $\left(\vec{u}_{\infty}, \vec{v}_{\infty}, \xi_{\infty}\right)$ is a minimiser of $\mathrm{I}_{\infty}$ in $\mathfrak{X}^{\infty}(\Omega)$. The choice $(\vec{u}, \vec{v}, \xi):=\left(\vec{u}_{\infty}, \vec{v}_{\infty}, \xi_{\infty}\right)$ in the above inequality implies

$$
\mathrm{I}_{\infty}\left(\vec{u}_{\infty}, \vec{v}_{\infty}, \xi_{\infty}\right) \longrightarrow \mathrm{I}_{p}\left(\vec{u}_{p}, \vec{v}_{p}, \xi_{p}\right)
$$

as $j \rightarrow \infty$. The proof of Proposition 7 is complete.
Before proving Theorem 2, we use it to obtain an additional piece of information on the variational inequality (1.20).

Corollary 8. In the setting of Theorem 2, in the case under assumption (1.15) (where $M=\infty$ and $\alpha>0$ ) the variational inequality (1.20) for the constrained minimiser implies the next test-function-free relations:

$$
\begin{array}{r}

$$

such that, $\left(\vec{u}_{p}, \vec{v}_{p}, \xi_{p}\right)$ satisfies

\begin{align*}
& \frac{1}{p}\left(\mathrm{dI}_{p}\right)_{\left(\vec{u}_{p}, \vec{v}_{p}, \xi_{p}\right)}\left(\vec{z}-\vec{u}_{p}, \vec{w}-\vec{v}_{p}, \eta-\xi_{p}\right) \\
& \quad \geq \sum_{i=1}^{N}\left\langle\left(\mathrm{dJ}_{i}^{1}\right)_{\left(\vec{u}_{p}, \vec{v}_{p}, \xi_{p}\right)}\left(\vec{z}-\vec{u}_{p}, \vec{w}-\vec{v}_{p}, \eta-\xi_{p}\right), \phi_{p i}\right\rangle  \tag{2.33}\\
& \quad+\sum_{i=1}^{N}\left\langle\left(\mathrm{dJ}_{i}^{2}\right)_{\left(\vec{u}_{p}, \vec{v}_{p}, \xi_{p}\right)}\left(\vec{z}-\vec{u}_{p}, \vec{w}-\vec{v}_{p}, \eta-\xi_{p}\right), \psi_{p i}\right\rangle
\end{align*}
$$

for any $(\vec{z}, \vec{w}, \eta) \in \mathscr{X}_{M}^{p}(\Omega)$. Since the convex set $\mathscr{X}_{M}^{p}(\Omega)$ can be written as the cartesian product of the vector spaces

with the convex set $\mathrm{L}^{p}(\Omega,[0, M])$ (see (2.25)), by replacing $\vec{z}$ by $\vec{z}+\vec{u}_{p}$ and $\vec{w}$ by $\vec{w}+\vec{v}_{p}$ in (2.33), we arrive at (2.32). The proof of the Proposition is complete.

By Proposition 11 we deduce that the variational inequality takes the form (2.34) below, as a direct consequence of $(2.20),(1.23),(1.24),(2.27)-(2.30)$.
Corollary 12. In the setting of Proposition 11, in view of the form of the Frechét derivatives of $\mathrm{I}_{p}$ and J , the variational inequality (2.32) takes the form

& \left.\quad+\int_{\partial \Omega}\left(\gamma z_{i}\right) \cdot \phi_{p i} \mathrm{~d} \mathcal{H}^{n-1}\right\}+\sum_{i=1}^{N}\left\{\int _ { \Omega } \left[\mathrm{~B}:\left(\mathrm{D} w_{i}^{\top} \mathrm{D} \psi_{p i}\right)\right.\right.  \tag{2.34}\\
& \left.\left.\quad+\left(\mathrm{L} w_{i}-\mathrm{M}\left(\left(\eta-\xi_{p}\right) u_{p i}+\xi_{p} z_{i}\right)\right) \cdot \psi_{p i}\right] \mathrm{~d} \mathcal{L}^{n}+\int_{\partial \Omega}\left(\gamma w_{i}\right) \cdot \psi_{p i} \mathrm{~d} \mathcal{H}^{n-1}\right\}
\end{align*}
$$

for any $(\vec{z}, \vec{w}, \eta) \in \mathscr{X}_{M}^{p}(\Omega)$.
We conclude this section by obtaining the further desired information on the variational inequality (2.34).
Lemma 13. In the setting of Corollary 12, the variational inequality (2.34) for the constrained minimiser $\left(\vec{u}_{p}, \vec{v}_{p}, \xi_{p}\right)$ is equivalent to the triplet of relations (1.20)(1.22).

Proof. The inequality (1.20) follows by setting $\vec{z}=\vec{w}=0$ in (2.34), and recalling the definition of Radon-Nikodym derivative of the absolutely continuous measure $\mu_{p}\left(\xi_{p}\right)$. The identity (1.21) follows by setting $\eta=\xi_{p}$ and $\vec{z}=0$ in (2.34) and by recalling that $\mathrm{W}^{1, p}\left(\Omega ; \mathbb{R}^{2 \times N}\right)$ is a vector space, so the inequality we obtain in fact holds for both $\pm w$. Finally, the identity (1.22) follows by setting $\eta=\xi_{p}$ and $\vec{w}=0$ in (2.34) and by recalling again that $\mathrm{W}^{1, \frac{m}{2}}\left(\Omega ; \mathbb{R}^{2 \times N}\right)$ is a vector space, so the inequality holds for both $\pm z$.

We conclude by establishing our last main result.

& \leq \frac{\int_{\mathrm{B}_{i}}\left(\left|v_{i}-\tilde{v}_{i}\right|_{(p)}\right)^{p-1} \mathrm{~d} \mathcal{H}^{n-1}}{\left(f_{\mathrm{B}_{i}}\left(\left|v_{i}-\tilde{v}_{i}\right|_{(p)}\right)^{p} \mathrm{~d} \mathcal{H}^{n-1}\right)^{\frac{p-1}{p}}} \\
& \leq 1
\end{aligned}

Similarly, we estimate

Further, by the sequential weak* compactness of the corresponding spaces of Radon measures, the estimates (2.35)-(2.36) imply the existence of a subsequence $\left(p_{j}\right)_{1}^{\infty}$ and of the claimed limiting measures $\left(\mu_{\infty}, \vec{\nu}_{\infty}\right)$ in (1.25). Note that the nonnegativity of $\mu_{\infty}$ follows from that of $\xi_{p}$ and hence of $\mu_{p}\left(\xi_{p}\right)$.

Next, we prove for later use the estimate

& =f_{\Omega} \frac{\left|\xi_{p}\right|_{(p)}^{p}}{\left(\left\|\xi_{p}\right\|_{\dot{\mathrm{L}}^{p}(\Omega)}\right)^{p-1}} \mathrm{~d} \mathcal{L}^{n}-\frac{1}{p^{2}} \int_{\Omega} \frac{\left(\left|\xi_{p}\right|_{(p)}\right)^{p-2}}{\left(\left\|\xi_{p}\right\|_{\dot{\mathrm{L}}^{p}(\Omega)}\right)^{p-1}} \mathrm{~d} \mathcal{L}^{n}
\end{aligned}
$$

which by Hölder inequality gives

Hence, for any $k \geq 1$ fixed and $p \geq k$, we have

We therefore discover (2.37) by letting $k \rightarrow \infty$.
Now we proceed with establishing (I) and (II) of the theorem.
(I) Suppose that $C_{\infty}=0$. Then, we have

as $p_{j} \rightarrow \infty$, where $\left(\vec{\phi}_{p}, \vec{\psi}_{p}\right)$ are the Lagrange multipliers associated with the constrained minimisation problem (1.18). In view of (2.37) and (1.19), the inequality (1.20) implies

duality pairing between $\mathrm{L}^{\frac{m}{2}}(\Omega)$ and $\mathrm{L}^{\frac{m}{m-2}}(\Omega)$, by letting $p \rightarrow \infty$ along the sequence $\left(p_{j}\right)_{1}^{\infty},(2.39)$ yields

& \left.+\int_{\partial \Omega}\left(\gamma w_{i}\right) \cdot \psi_{p i} \mathrm{~d} \mathcal{H}^{n-1}\right\}
\end{aligned}
$$

for any $\vec{w} \in \mathrm{C}_{0}^{1}\left(\bar{\Omega} ; \mathbb{R}^{2 \times N}\right)$. Therefore, $\vec{\nu}_{\infty}=\overrightarrow{0}$, as claimed.
(II) Suppose now that $C_{\infty}>0$. Then, the desired relations (1.27)-(1.29) would follow directly from (2.39) and (1.21)-(1.22) by rescaling $\left(\vec{\phi}_{p}, \vec{\psi}_{p}\right)$ and passing to the limit as $p_{j} \rightarrow \infty$ since the rescaled multipliers $\left(\vec{\phi}_{p} / C_{p}, \vec{\psi}_{p} / C_{p}\right)$ are bounded in the product space

\leq & \int_{\Omega}\left|\xi_{p}\right|\left|\left(\mathrm{M} u_{p i}\right) \cdot \frac{\psi_{p i}}{C_{p}}-\left(\mathrm{M} u_{\infty i}\right) \cdot \psi_{\infty i}\right| \mathrm{d} \mathcal{L}^{n}  \tag{2.41}\\
& +\left|\int_{\Omega}\left(\xi_{p}-\xi_{\infty}\right)\left[\left(\mathrm{M} u_{\infty i}\right) \cdot \psi_{\infty i}\right] \mathrm{d} \mathcal{L}^{n}\right|
\end{align*}
$$

Note now that by Theorem 1 we have $\xi_{p} \longrightarrow \xi_{\infty}$ in $\mathrm{L}^{q}(\Omega)$ for any $q \in(1, \infty)$ as $p_{j} \rightarrow \infty$. In view of (2.41), to conclude with (2.40) we need to show that there exists $t>1$ such that

To this end, recall that by Theorem 1 we have $u_{p i} \longrightarrow u_{\infty i}$ in $\mathrm{W}^{1, \frac{m}{2}}\left(\Omega ; \mathbb{R}^{2}\right)$ as $p_{j} \rightarrow \infty$. By this bound and the a.e. convergence as $p_{j} \rightarrow \infty$, the Vitali convergence theorem implies

In order to show the above choices are admissible, we need to prove that $0<\kappa<1$. To this aim, we readily have that $\kappa>0$ because $m<2 n$. Next, note we also have

$$
1-2 \frac{m-n}{n m}<1
$$

because $m>n$. Further, we have the equivalence

$$
\frac{2 n-m}{n m}<1 \Longleftrightarrow m>\frac{2 n}{n+1}
$$

and given that $m>n$ and $\frac{2 n}{n+1}<2$, we deduce that $\kappa<1$. Next, we choose

$$
s:=\left(\frac{n m}{2 n-m}\right)\left(\frac{1-\varepsilon}{r}\right)
$$

Then, our earlier choices of $r, \varepsilon, \kappa$ imply that $s$ is an admissible choice, since

$$
s=\frac{n m \kappa}{2 n-m} \geq\left(\frac{n m}{2 n-m}\right)\left(\frac{2 n-m}{n m}\right)=1
$$

Note further that

$$
r s^{\prime} \leq \frac{n(1-\varepsilon)}{n-1}
$$

as the above inequality can be easily seen that is equivalent to

$$
\kappa \geq 1-2 \frac{m-n}{n m}
$$

and the latter inequality is true by the definition of $\kappa$. In conclusion, by Hölder's inequality and the above arguments, (2.46) yields

$$
\begin{equation*}
\int_{\Omega}\left|\left(\mathrm{M} u_{p i}\right) \cdot \frac{\psi_{p i}}{C_{p}}\right|^{r} \mathrm{~d} \mathcal{L}^{n} \leq\left(\int_{\Omega}\left|\mathrm{M} u_{p i}\right|^{\frac{n m(1-\varepsilon)}{2 n-m}} \mathrm{~d} \mathcal{L}^{n}\right)^{\frac{1}{s}}\left(\int_{\Omega}\left|\frac{\psi_{p i}}{C_{p}}\right|^{\frac{n(1-\varepsilon)}{n-1}} \mathrm{~d} \mathcal{L}^{n}\right)^{\frac{r(n-1)}{n(1-\varepsilon)}} \tag{2.47}
\end{equation*}
$$

In view of (2.44)-(2.45), (2.42) ensues from (2.47) for any $t \in(1, r)$. Finally, (2.43) also follows from (2.47) and the Vitali convergence theorem, as from (2.44)-(2.45) we already know

$$
\left(\mathrm{M} u_{p i}\right) \cdot \frac{\psi_{p i}}{C_{p}} \longrightarrow\left(\mathrm{M} u_{\infty i}\right) \cdot \psi_{\infty i} \quad \text { a.e. on } \Omega
$$

as $p_{j} \rightarrow \infty$, because $\mathrm{M} \in \mathrm{L}^{\infty}\left(\Omega ; \mathbb{R}^{2 \times 2}\right)$. The theorem ensues.
